I agree to pay my son's tuition, Homestay, camp fees and such other charges as may become payable during the period of the student's enrolment at Whitefriars College.

I agree that my son may be photographed for school information purposes.

I acknowledge that:

1. Any variation of the terms and conditions of this agreement will be notified as per Guide to Fees issued each year or advised in writing and signed by the Principal.
2. If after payment of tuition fees to Whitefriars College my son does not begin studies at Whitefriars College or leaves Whitefriars College before completion of the period for which fees have been paid, any refund will be in accordance with the College Refund Policy.
3. My son must attend all lessons, classes, tests and examinations, class excursions and camps during his studies and abide by the rules and regulations of the College that are in force at any time.
4. The College reserves the right to require my son to leave the College at any stage if he does not, without good reason, fulfil the requirements expressed in 3 above, or if his misconduct is such that his presence would in the opinion of the College, be detrimental to other students of the College. In such an event, any fee refund is most unlikely.
5. In the event of circumstances requiring immediate medical care when it is not possible to communicate with me, the College is authorized to seek and provide appropriate medical care for my son.
6. If my son wishes to leave the College, one term's notice in writing must be given to the Director- International Student Program otherwise one term's tuition fees must be paid.
7. If my son wishes to leave the College approved accommodation, at least 4 weeks written notice must be given by me. If notice is not given, a month's Homestay and Support program is forfeited.

Whitefriars College acknowledges that:

1. It will refund the tuition fees, OSHC fees and Homestay and Support Program fee less \$100.00AUD administrative costs if entry to Australia is refused by the Australian Immigration authorities. (Refer to written agreement No.7 Refund of course monies)
2. Before a refund can be issued for tuition and/or Homestay payments, one term's notice in writing must be given by the parents to the Director-International Student Program.
3. The agreement does not remove the right to take further action under Australia's consumer protection laws.
